

I-3. Login

To login to the web management interface and configure the switch's settings, connect a computer to the switch using an Ethernet cable. Open a web browser and go to the switch's IP address. The default IP address is **192.168.2.1.** Your computer's IP address must be in the same subnet as the switch. For the default IP address this is any IP address in the range **192.168.2.x** ($\mathbf{x} = \mathbf{2} - \mathbf{254}$). You can modify the IP address of your computer if you need.
